## Preface

This Environmental Impact Assessment Report (EIA Report) has been prepared in support of an application by EDF Energy Renewables Ltd (EDF-ER) ('the Applicant') to the Scottish Government Energy Consents Unit (ECU) for Section 36 consent to construct and operate Dunside Wind Farm (the 'Proposed Development'). The proposed site (the Site) is located approximately 6 km north of Westruther and 7 km west of Longformacus in the Scottish Borders Council (SBC) administrative area. The Proposed Development will comprise up to 15 wind turbines with battery storage and other associated infrastructure.

The EIA Report comprises the following volumes:
